Students appearing in TDC (CBCS) 2nd and 4th Semester exam 2023 are hereby directed to fill up their Online Admission form for 2nd year (3rd & 4th Sem) and 3rd year (5th & 6th Sem) classes of 2023-2024 session by using the college Online Admission portal from 9th Aug'23 to 12th Aug'23 and get themselves admitted by paying the requisite amount of Admission fees through college office and submit the printed copies of Online Admission form along with uploaded documents.

Fees are to be paid :

B.A Pass Course -3660/-

B.A Hon's Course – 3660/-

And BPL categories students of B.A Pass & Hon's (both) – 450/- only.

Applicants who have been selected for fee waiver, he/she must have to pay Rs-450/- only as (i) Game and Sports fees Rs.200/- (ii) College Magazine fees Rs.150/- and (iii) Union fees Rs.100/-

As per DHE's letter no- **PC/HE/Misc/42/2020/235** dated **29/06/2022**, the fee waiver scheme will be continued for the session 2023-24 for regular students having 75% of class attendance and have no any Back / Arrear paper(s) in previous TDC examination.

Students having back papers in any semester are not entitled to get the Fee Waiver Scheme benefit as per Govt. order.

- viii) Undertaking which has uploaded in college website.
- ix) Photograph of the Sapling planted which was planted in the time of taking admission into B.A. 1st Semester / B.A. 3rd Semester in 2022-2023 Session.
- x) Domicile Certificate, Voter ID/ PRC/ Self or Parent Aadhaar Card etc.
- xi) Scanned copy of previous AUS Exam Mark sheet.
- xii) AUS Registration Card.
- xiii) Updated DHE Registration Copy.


As an alternative to the income certificate issued by the Circle Officer as stated in the OM, the Head of the institution from where the student has passed out may also issue an Income Certificate for the purpose of the fee waiver scheme and the same shall be accepted by the institution admitting the students.

OR

The Head of an Institution where a student is seeking admission may admit a student under fee waiver scheme if he / she is satisfied that the annual income of the parents of the student is below Rs. 2 Lakhs, per annum by recording their satisfaction and issuing an Income Certificate in favour of the student for the purpose.
