Students who appeared in TDC (FYUGP) 2nd Semester exam 2024 are hereby directed to fill up their Online Admission form for 2nd year (3rd & 4th Sem) classes of 2024-2025 session by using the college Online Admission portal i.e., <https://svcollegecdk.ac.in/portal/student/student-login.html> from 19th Aug'24 to 22nd Aug'24 and get themselves admitted by paying the requisite amount of Admission fees through QR Scanner and submit the printed copies of Online Admission form along with uploaded documents.

Students Fee Waiver Applicability :

1) Category of students eligible under the scheme:

- (i) Students whose parental annual income is less than Rs. 2.00 lakh from all sources will be eligible to avail the scheme.
- (ii) If either of the parent (mother or father) of the students is working in the State Govt./ Central Govt./ Semi Govt./ State or Central Govt. undertakings, such students shall not be eligible under this scheme.
- (iii) Scheme is only for regular students having minimum 75% of attendance in classes with no back paper in previous examination to be eligible for fee waiver claim in subsequent semesters of study.
- (iv) Photo of the sapling planted by the candidate during 1st Semester Admission, displaying details of the sapling as per Government instructions.

2) Proof of Income/Documents required:

- (i) An Income Certificate issued by the Local Revenue Circle Officer.

OR

Ration Card issued by the Competent authority.

- (ii) A declaration from the students that neither of the parents (father or mother) of the students in an employee of the State Govt./ Central Govt. department or its undertaking. Such form shall be devised by the concerned Principal. If such a declaration is found to be false, the admission shall be cancelled and the admission fee shall be realized from such students.

- (iii) Undertaking form can be downloaded from the college website.

The following documents are to be uploaded in the College Website.


- i) Passport Size Photograph.
- ii) Students Signature.
- iii) Guardians Signature.
- iv) Age proof certificate.
- v) Bank passbook.
- vi) Fee payment receipt of AUS of 2nd Semester exam 2024.
- vii) 3rd Semester Admission Fee payment (Online) receipt of S.V College .
- viii) Income Certificate from Circle officer / Ration Card .
- ix) Declaration which has uploaded in college website.
- x) Domicile Certificate, Voter ID/ PRC/ Self or Parent Aadhaar Card etc.
- xi) Scanned copy of all previous AUS Exam Admit & Mark sheet.
- xii) AUS Registration Card.
- xiii) Updated DHE Registration Copy.
